

AFFIDAVIT FOR ARREST WARRANT

THE STATE OF TEXAS

COUNTY OF ELLIS

BEFORE ME, the undersigned authority, on this date personally appeared the undersigned affiant, who, after being duly sworn by me, on oath stated:

My name is T. B. Woodruff, badge no. 115. I am a duly sworn Peace Officer and have been employed by the Waxahachie Police Department, Ellis County, Texas, for over seventeen years. I have been assigned as a Detective to the Criminal Investigation Division since 1996.

On 6-24-10 at 1:02 pm, affiant received a report from the Waxahachie Police Department dispatcher that a young girl had just possibly been sexually assaulted at the apartments at 200 High School Dr , Waxahachie TX. Affiant and a fellow officer, Det. Sgt. R Guthrie, immediately went there where Sgt. Guthrie spoke with Cassidy (pseudonym), an eight – year old female who lives at that apartment complex, and her mother. Cassidy told Guthrie that she had just gone to the apartment of a man who sells candy at the apartment complex there. She told Guthrie that this man, “pulled my panties down and stuck his pee-pee in my butt”. She indicated to Guthrie that this occurred just prior to officers arriving at the complex. She told her mother and her mother called police.

Cassidy was able to point out to Det. Guthrie and Affiant the apartment where this occurred. Affiant saw Cassidy point to apartment #25 at the complex. Cassidy’s mother told affiant that she was familiar with the man at that apartment. She described him as a black man in his fifties.

Affiant then called and spoke with a representative of Dollar Properties, the company that manages the apartment complex. Affiant asked the representative who lives at apartment #25 at that complex. The representative told affiant that a man named Gene Loftis lives in apartment #25 with his wife. He described Mr. Loftis as a black man in his fifties.

Affiant left Sgt. Guthrie with Cassidy and drove back to the Police Station. Affiant found a “mug shot” from a 2003 Waxahachie PD arrest report of a Waxahachie man named Gene Loftis. Mr. Loftis is a black male and is 56 years old. Affiant generated a photo array containing this mug shot and mug shots of five other black men.

Affiant gave the photo array to fellow Sgt. Detective B. Doughty. Doughty drove back to Det. Guthrie and Cassidy at the apartment complex to show her the array. Det. Doughty soon called and told affiant that Cassidy had just pointed out the photo of Gene Loftis as the man that did this to her.

Det. R. Clayton then drove Cassidy to Cook Children’s Hospital.

Affiant has obtained further identification information on Gene Edward Loftis from the aforementioned arrest report, to include his height , social security number and his date of birth.

Therefore, affiant requests issuance of a warrant of arrest for **Loftis, Gene Edward**, a black male, whose date of birth is 02/11/1954, pursuant to section 22.021 of the Texas Penal Code, for the offense of **Aggravated Sexual Assault of a Child**, a felony.




