The portion of Baucum is approximately 1.10 miles in length. The work on Baucum Road will include reclamation of the existing roadway, the addition of base as needed, and a 2 course treatment on the surface (i.e. chip and seal). The Baucum Road Work will not start until the bulk of the heavy equipment is moved off the TRWD IPL project. Paul Perry, Commissioner, Pct. 3
