<u>PLATTING, SUBDIVISION & ENGINEERING FEES</u> <i>(TLGC 232.021)</i>	AMOUNT*
Plats	\$550 + \$50 per lot
Engineering Plan Review/ Infrastructure Development Plan (IDP)	The greater of \$1,000 or \$1 per linear foot of new roads/streets/drives (public or private)
Plat or Engineering Plan Resubmittal <i>(Applies to plat or engineering plan review entering its 3rd and subsequent rounds of revision prior to action)</i>	Half the cost of the applicable plat or engineering fee
Flood Study Review <i>(TWC 16.315& 16.324)</i>	\$500 + cost of 3 rd party review (as needed)
Subdivision Percentage Fee <i>(ECCC Revenue Fund)</i>	3.5% of infrastructure costs (roads & drainage only)
Subdivision Inspection Fee <i>(TLGC 232.0305)</i>	\$0.50 per linear foot (new construction) \$0.25 per linear foot (existing roads)
Plat or Engineering-related Variance/Appeal/ROW Abandonments	\$375
Misc. Platting, Subdivision & Engineering Fees	\$150



<u>SEPTIC FEES</u> <i>(TAC 285.11)</i>	AMOUNT*
Any septic system	\$600
Alteration/Hook-To/Re-inspection/Repair	\$175
Septic-related Variance/Appeal	\$375
Misc. Septic Fees	\$150



<u>OTHER FEES</u>	AMOUNT*
Culvert Permit <i>(TWC 16.324)</i>	\$50
Junkyard/Salvage Yard License & Renewals <i>(TTC 396.041)</i>	\$25
Slaughterhouses <i>(TLGC 234.034)</i>	\$1,000
