Construction Permit INFORMATION SHEET

All construction and demolition activities must comply with the general safety precautions found in Chapter 33.

No person shall perform or authorize Construction or Substantial Improvement within the unincorporated areas of Ellis County without first securing a permit.

The following documents must be submitted with the permit application:

- a) A copy of the firm's Alarm Certificate of Registration
- b) Two copies of plans indicating the location of all detection, notification and supervisory devices.
The plans must also show the number of devices.
- c) A completed Construction Permit Application

A permit fee in accordance with the Ellis County Fire Code.
