## **Automatic Fire-extinguishing System Permit Information Sheet**

In order to obtain a permit, the following items must be submitted:

1. A completed Permit Application.
2. Two complete sets of system construction plans for each building, drawn to scale and must include:
  - a. The location of any fire alarm equipment required to meet the Fire Code.
3. Identification of the System Designer
4. Identification of the System Installer
5. A permit fee in accordance with the Ellis County Fire Code.

The plans will be reviewed by the Fire Code Official and, if necessary, revisions will be marked up on the plans. Upon approval, the plans will be stamped and one (1) set of plans will be retained at the Fire Marshal's Office. The remaining set must be kept at the construction site. A Building Permit will also be issued and must remain at the construction site and must be visible from the roadway. ***Address numbers assigned by the 911 Coordinator must also be visible and legible from the roadway during the entire construction process.***

When the construction process is completed and the building is ready to be occupied, a "Request for Final Inspection" form must be completed. Once the form has been received by the Fire Code Official, a final inspection will be scheduled. ***A building cannot be occupied until it has passed a final inspection and received a Certificate of Completion.***
