ITEMS TO BRING ALL APPLICANTS MUST APPEAR IN PERSON!!!! NO EXCEPTIONS!!!

1. PROOF OF U.S. CITIZENSHIP: An original or certified birth certificate or previous issued passport not issued over 20 years. AND a photocopy of document.
2. PROOF OF IDENTITY: You must present your original identification (non-expired) AND submit a photocopy of the front and back with your application.
3. PASSPORT PHOTOS: Photographs must meet passport requirements – full front view and 2x2 inches in size. WE DO NOT OFFER THIS SERVICE AT OUR LOCATION. See below for photo suppliers in the area.

5. EXECUTION FEE: \$35.00. This fee is paid separately and will be payable to the Ellis County District Clerks Office. We accept cash or debit/credit cards. NO CHECKS.

REQUIREMENTS FOR CHILDREN:

To submit an application for a child under the age of 16 both parents or the legal guardian(s) must appear and present the following:

- Evidence of the child's US citizenship;
- Evidence of the child's relationship to parents/guardians(s); AND
- Original parental/guardian government-issued identification AND a photocopy of the front and back of presented identification.

IF ONLY ONE PARENT APPEARS, YOU MUST ALSO SUBMIT ONE OF THE FOLLOWING:

- DS-3053 STATEMENT OF CONSENT – (include the child’s full name and date of birth) consenting to the passport issuance for the child. This statement must be notarized and cannot be more than **three** months old and must be signed and notarized on the same day, and must come with a photocopy of the front and back side of the second parent’s government-issued photo identification, OR
- Second parent’s death certificate if second parent is deceased, OR
- Primary evidence of sole authority to apply, such as a court order, OR
- A written statement or DS-5525 (made under penalty of perjury) explaining in detail the second parent’s unavailability.

PASSPORT RENEWALS

- Children 15 years and younger must renew in person and complete the DS-11 application. They are not eligible to complete the DS-82 Renewal application.
- Adults may submit the DS-82 application through the mail. If applying through the mail, there is no execution fee. Pay only the application fee. We cannot accept the DS-82 form. If you would like your application processed with an agent in our office, please complete the DS-11 application as your renewal. Please follow the above fee schedule.
